What Is Live Lawyer™

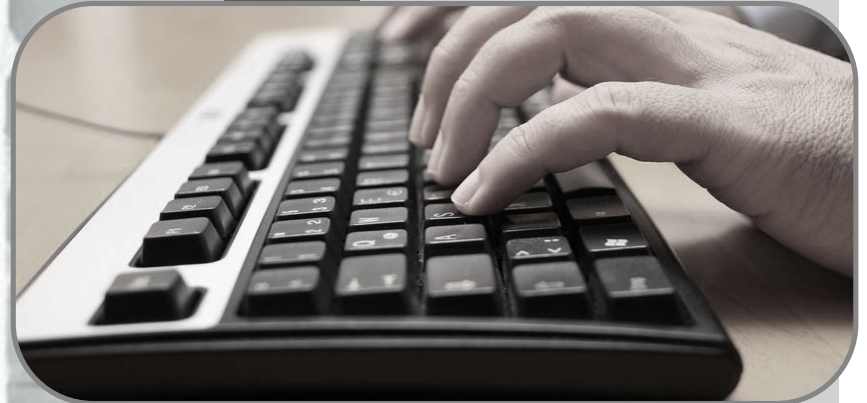
